RULES OF DISCIPLINE/CODE OF CONDUCT

(Academic Year 2025-26)

- 1. The student should be present in the class room before the lecture starts and till it finishes and in the laboratory during practicals till the given experiment is completed.
- 2. The student will not be eligible to appear for Annual examination and Sessional examination if he/she fails to fulfill 75% attendance in the classes in an academic year.
- 3. The student should wear neat and clean uniform while academics and college activities.
- 4. Students should pay timely prescribed fee of college.
- 5. The student should go to library instead of roaming in the corridor during free time.
- 6. The student should not remain absent in the college without prior permission from class teacher.
- 7. The student should inform their parents regularly about their attendance and progress in academies.
- 8. The student should be obedient and respectful to teachers, librarian, administrative staff and other supporting staff in the college.
- 9. All the internal and Savitribai Phule Pune University examinations should be attended by the student.
- 10. Discipline should be followed strictly during examinations.
- 11. The ID card should be worn in the college premises.
