## <u>RULES OF DISCIPLINE / CODE OF CONDUCT</u> (Academic Year 2023-24)

- 1. The student should be present in the Classroom before the lecture starts and till it finishes and in the laboratory during practicals till the given experiment is completed.
- 2. The student will not be eligible to appear for the Annual examination and Internal Sessional examination if he/ she fails to fulfill **75 % attendance** in an academic year.
- 3. Students should keep the phone on silent mode at the time of class.
- 4. Students should pay the timely prescribed fees of college.
- 5. The student should go to the library instead of roaming in the corridor during free time.
- 6. The student should not remain absent in the college without prior permission from the class teacher.
- 7. The student should regularly inform their parents about their attendance and academic progress.
- 8. The student should be obedient and respectful to the college's teachers, librarian, administrative staff, and other supporting staff.
- 9. The student should wear a neat and clean uniform and observe personal hygiene
- 10. The student should attend all the internal and Savitribai Phule Pune University examinations.
- 11. Discipline should be followed strictly during examinations.
- 12. The ID card should be worn in the college.
- 13. The students should not smoke, drink and chew tobacco, etc in as well as out of college.
- 14. The student can participate in industrial/education tours only. He/she is not allowed to participate in any other tours without college approval.
- 15. The groupism, processions, protestations, mobbing, movements, etc are strictly prohibited in the college premises.
- 16. The student should read the notices displayed on the notice board/website of the college/ shared on the official WhatsApp group regularly.
- 17. Any grievance should be communicated to the respective class teacher, academic incharge, exam incharge or respective responsible staff.
- 18. The Secretary of the Anti-ragging Committee should be immediately informed in case of ragging.
- 19. The student should participate in all the activities conducted in the college.
- 20. Cleanliness should be maintained in the campus.
- 21. The student should not impose any kind of external pressure in the conduct of college activities.
- 22. There should not be 'common off' in the college.
- 23. The students should not collect funds from other students for any activity in the college without prior permission of the college authorities.
- 24. To play mischief with, to pressurize, or to frighten the girl students in the college premises is strictly prohibited. The victim should make a complaint to the Presiding officer, 'The Ladies Grievance Redressal Committee'. The guilty will be punished accordingly.

- 25. To entertain any other person or ex-students for private meetings in the college is not allowed.26. If any kind of misconduct is done by the student he/she should be punished or rusticated from the college.
